Attorneys representing the City of Vinita and the Vinita Utilities Authority ("VUA") announced the settlement of a long-standing public finance lawsuit pending before the District Court of Craig County in Case No. CJ-2015-9, in return for the payment unto the City of Vinita and the VUA of the sum of \$375,000, plus payment of all mediation expenses incurred in obtaining the settlement. A prior settlement of earlier litigation against other parties had resulted in a savings for the City of Vinita in excess of one-half million dollars.

This will amicably conclude all remaining litigation arising from the City of Vinita's Wi-Fi and automatic meter reading system.
