Chairman Stephanie Hoskin reported that the committee reviewed the current rates for water, sewer, and trash. The water and sewer rates have not been increased since 2009 and the

commercial trash was last adjusted in 2017. According to the U.S Bureau of Labor Statistics, the Consumer Price Index (CPI) category for water and sewer and trash collection services has experienced an average inflation rate of 4.30% each year from 2009 to 2022. On February 1, 2022, Waste Management of Oklahoma, Inc, increased the fees charged to the Authority's trash disposal site, Quarry Landfill, by 4.79%. With the CPI increase each year since 2009 the committee will propose to the Authority the new rates beginning September 1, 2022 at an increase of 4.79% for the three services provided by the Authority.
