Fire Chief Kevin Huxtable said the call rate was almost a new monthly record. The department applied for a Federal Grant for a tanker. This grant is a high priority grant and many applications are sent in.

City Clerk Brian Prince reported that he will be presenting the VIDA Phase slide show to the Lions Club this week. There was a safety meeting this afternoon attended by most of the employees. Also noted that he was continuing to work with Allen Goforth on several grant opportunities.

Mayor Chuck Hoskin gave a good report on the waterline break on January 31, 2023. He noted that the cold frigid temperatures did not stop the VUA employees from completing a huge undertaking on a water leak. He stated that not once did he ear any complaints about the cold. He heard employees stating we got to get the water back on and they did everything they could to make that happen in a timely manner. Not only did he recognize the VUA he noted that the trash, fire, police and street were all doing their part to keep the city running in the icy conditions. The library and City Clerks office were also open to assist anyone who needed services or just a warm place to walk into.
