ORDINANCE NO. 3824

AN ORDINANCE ANNEXING TO THE CORPORATE LIMITS OF THE CITY OF VINITA, OKLAHOMA CERTAIN TERRITORY AND EXTENDING THE CITY LIMITS OF SAID CITY TO INCLUDE SAID TERRITORY; AND DECLARING AN EMERGENCY

WHEREAS, on September 26, 2023, the City Council of the City of Vinita, Oklahoma, following a public hearing regarding the proposed annexation of certain territory more particularly described on Exhibit "A" attached hereto to the corporate limits of the City of Vinita, Oklahoma, directed the drafting of this ordinance extending the corporate limits of the City of Vinita, Oklahoma to encompass and include said territory more fully described on Exhibit "A" attached hereto and made a part hereof by reference, thereby incorporating the same into said City;

WHEREAS, the City Council of the City of Vinita, Oklahoma, has jurisdiction pursuant to Okla. Stat. tit. 11, § 1-103 (A), as the owners of sixty-five percent (65%) of the land and twenty-five percent (25%) of the population within the described real property has previously expressed in writing their consent to the formal annexation of said property and the extension of the corporate limits of the City of Vinita, Oklahoma, to incorporate the same through a written Consent to Annexation;

WHEREAS, the said territory more fully described on Exhibit "A" encompasses fourthousand three-hundred seventy-six (4,376) acres more or less; and

WHEREAS, the Mayor and City Council of the City of Vinita, Oklahoma have found that the annexation of said territory serves valuable municipal purposes, is desirable and in the best interest of the City of Vinita, Oklahoma; and that said property should, therefore, be formally annexed to the City of Vinita, Oklahoma;

NOW THEREFORE, be it hereby ordained by the Mayor and the City Council of the City of Vinita, as follows:

SECTION I

That the corporate limits of the City of Vinita, Oklahoma be, and the same are hereby extended to incorporate the lands and premises more particularly described on Exhibit "A" attached hereto, the content of which is herein incorporated by reference, thereby formally annexing said lands and premises to the City of Vinita, Oklahoma.

SECTION II: Emergency

Declaration of Emergency. That for the preservation of the public health, peace and safety of the citizens of the City of Vinita, an emergency is hereby declared to exist by reason of

passage by the Council and its immediate publication thereafter, according to law.

- I am updating Phase II information on the Dept of Commerce website as well as providing information to local realtors on how to list commercial property available in Vinita.
- I met with Shannon Duhon from Miami Area Economic Development Services regarding their revolving loan fund available to businesses in Craig County.
- Brian and I will be attending the annual economic development summit hosted by Northeastern Oklahoma Regional Alliance on Oct 24 at NSU.
- Working with NTC and the Vinita Area Chamber in developing and promoting a "Shop Small" campaign for the holidays.
